Need a check for fire hazards; AHPSI guards will do it for you

Our guards are especially trained for fire watch duty. Our guards will familiarize themselves with your facility and continuously patrol the entire premises for the purpose of detecting fires and transmitting an immediate alarm to the Fire Department and building occupants. Our guards will login in the fire watch log every half hour as required by the fire marshal. The fire log will be kept at the property for management and fire marshal for review. Patrol required at least once every 15 minutes if the facility has people sleeping, is an institutional facility, or is an occupied assembly facility. If vacant than: Patrols are required every 30 minutes for all other facilities.

We offer the following services for fire watch:

- Make reports as instructed. A written record of patrol in a fire log book provided either by client or AHPSI
- Patrol the designated areas
- Be thoroughly familiar with the area the fire marshal designated as fire hazard
- Guard will remain on duty until his properly relieved
- Report hazards to management
